**Christian Service Center provides clients with clothing, food, and/or other needed items or services free of charge through several programs operated by the Center. Standing in the Gap program provides funds when clients are in need of items such as transportation, medication, utilities and rent. Feed the Hungry program provides food to those in need. During the year approximately 1,400 orders for food were filled. Operation Blue Jeans provides new clothes for school as well as school supplies. Over 400 children received school clothes and over 850 children received school supplies. Clients are also offered a Bible, bible study, and/or a time of prayer with a minister or volunteer. Overall approximately 8,300 people were served through the Center.**
