Operation Blue Jeans provides new clothes for school as well as school supplies. Over 400 children received school clothes and over 850 children received school supplies. Clients are also offered a Bible, bible study, and/or a time of prayer with a minister or volunteer. Overall approximately 8,300 people were served through the Center.
